Purpose and Overview of Role

The role is within the Production Systems Group (PSG) in Geneva, part of the Technical Operations (Tech Ops) team. The Tech Ops function ensures the smooth operation of our IT Infrastructure, software and change process on a 24 hour basis. The function encompasses the following teams;

- Production Systems Group
- Quality Assurance (QA)
- Data Operations
- Infrastructure management
- Cyber security

PSG are the first line technical support team for the Systematica trading and middle office IT platform, supporting a 24x6 global trading business. The team operates from Geneva, London, Singapore and New York.

QA operate a testing regime to ensure that software delivery is reliable and robust.

Data Operations on-board new data sources into the organisation, facing external vendors and also provide 24x6 support for the core data platform underpinning the global trading platform.

The Infrastructure team faces off to our primary infrastructure provider 'Options IT', monitoring the SLA and change management activities.

PSG is a technically diverse team, focused on the continual delivery of the day to day operations of the automated trading platform. Team members need to collaborate well which often requires flexible problem solving and a commitment to understanding technically complex issues. No day is ever the same in PSG. This is an opportunity for an engineer with a demonstrated commitment to support and technical operations to join the Geneva team, working closely with the trading, research and development groups and become an integral part of the business activity.

Primary Duties

- Ensure continued operation of production systems;
- Resolving issues and queries, working with the wider business or groups in other offices where appropriate;
- Co-ordinate and effect change across the infrastructure alongside other Tech Ops groups; and
- Developing the support capabilities and knowledge of the team.
